Judging Criteria: Judges look at the following to determine a quality product: appearance of pack, head space, preparation and selection of canned products. All canned items must be processed and sealed according to USDA standards. (Contact the Extension Office if you have any questions about this process, publication FCS3-325.) Paraffin may not be used. Entries must be in an approved pint or quart jar with rust free rings and lids. (Half pints for jams and jellies only.) All items must be labeled with a permanent marker directly on the lid with the name of the product and the date (month and year) when it was processed. Jars may be opened at the discretion of the judges. Only items canned during the previous year may be eligible to win a premium.

All culinary items, including cakes, must be displayed on a white disposable plate in a large zipper bag. Pies must be in a 9" disposable pie plate in a zipper bag. No glass plates. No fresh fruits may be used to garnish. No commercial mix is allowed in any category, including icings. Store bought pie crust may be used for pies.
